COMPLAINT

The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s):

COUNT I

CONTROLLED SUBSTANCE CRIME IN THE FIRST DEGREE

M.S. § 152.021, subd.1(1), subd.3(a); and 609.101

That on one or more occasions within a 90-day, including July 8, 2009, in Dakota County, Minnesota, ALFREDO MEDINA did unlawfully sell one or more mixtures of a total weight of ten grams or more containing methamphetamine.

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

I, the undersigned, am an agent with the Drug Enforcement Agency. Acting in that capacity, I have investigated this matter, reviewed the statements and reports of others, and state that the following facts are true and correct to the best of my knowledge and belief.

On July 8, 2009, an agent with the United States Department of Justice Drug Enforcement Administration (DEA) made arrangements through a Confidential Informant (CI) to purchase a quantity of methamphetamine from a person the CI knew as "Louie". Pursuant to these arrangements, the CI drove to a location in the city of West Saint Paul, Dakota County, Minnesota, to purchase the methamphetamine. Prior to driving to the location, the CI and his/her vehicle was searched by agents for monies and controlled substances. No controlled substances or monies were found. A DEA agent gave the CI an amount of government money to purchase the methamphetamine. The CI was then kept under constant surveillance by DEA agents as he/she drove to the West Saint Paul location. After arrival at the location, the CI parked his/her vehicle and waited for "Louie" to arrive. A short time later, surveillance officers observed a pick-up truck arrive at the location and park near the CI's vehicle. Surveillance agents observed a man exit the pick-up truck and walk over to the CI's vehicle and meet with the CI. Surveillance agents observed the man return to his pick-up truck and drive away. Surveillance agents kept the CI under surveillance as he drove to a predetermined location. Upon arrival at the predetermined location, the CI gave DEA agents a quantity of substance that was subsequently submitted to DEA laboratory where it tested positive for methamphetamine. The approximate weight of the substance was 27 grams.

In a subsequent statement to DEA agents, the CI indicated that he purchased the methamphetamine from the person in the pick-up truck. Subsequent investigation determined that the pick-up truck registered to Alfredo Medina (D.O.B. 3-27-1985). As part of a follow-up examination, DEA agents obtained a driver's license photo and physical description of Alfredo Medina, the registered owner of the above pickup truck. The photograph and physical description matches the person DEA surveillance officers meeting with the CI and who the CI indicated he purchased the methamphetamine from.
